- 2024 Summer CSA (11 weeks) July 2–September 14 — \$348.50** (includes CSA, tax and \$10 charge for 2 reusable Miller Farms cloth shopping bags that are yours to keep)
You are paying \$30/week for \$30 worth of produce. Your Share will contain a weekly selection of produce and or product from our Market for 3-4 people for 11 weeks. You will get one Share of produce each week. Remember to bring your Miller Farms Bags when you pick up your share.
- 2024 Fall CSA (11 weeks) September 16–November 30 — \$348.50** (includes CSA, tax and \$10 charge for 2 reusable Miller Farms cloth shopping bags that are yours to keep)

2024 Payments and deadlines:

We accept Master Card, Visa, Discover, and AMEX. Pay in full by **January 13** and get a 5% discount.

Payments for Full Season memberships and Spring memberships are due **April 13**. Summer memberships are due **June 29**.

Fall membership are due **September 14**. Sign-ups after the deadlines are assessed a \$25 late fee.

CSA Detailed Information

- Duration:** The duration of our Full Season CSA is 33 weeks. The duration of our Spring, Summer, and Fall CSA seasons are 11 weeks each.
 - Full Season:** April 15—November 30, 2024.
 - Spring CSA season:** April 15—June 29, 2024.
 - Summer CSA season:** July 2—September 14, 2024.
 - Fall CSA season:** September 16—November 30, 2024.
 - Each CSA membership will contain coupons for items or produce from our market.
- Payments:**
 - Full CSA:** payment is due in full by [April 13, 2024](#).
 - Spring CSA:** payment is due in full by [April 13, 2024](#).
 - Summer CSA:** payment is due in Full by [June 29, 2024](#).
 - Fall CSA:** payment is due in Full by [September 14, 2024](#).
 - Your Payment is NON-REFUNDABLE.
- Discounts:** If you sign-up for any of our CSA's and pay in full by [January 13, 2024](#), you will receive a 5% discount.
- Special requests:** If you would like additional produce for a special event or for freezing/canning, let us know and we will be happy to provide you with an estimated cost and availability.
- “Ready-to Go” CSAs**

Pick-up times: You must select one designated pick-up day that remains in effect during the length of the agreement. See the application for more details concerning vacations, etc. We encourage you to coordinate pick-ups with friends to help save time and gas. Choices are:

“Ready-to-Go” Produce Selection: Our goal is to provide you with a selection of fresh, high quality produce that is equivalent to \$30 retail value per week. On most weeks the value of your share will exceed the share value especially during the middle of the growing season. We package all CSA shares with the same quantity of produce for each customer. We understand that everyone has preferences, but at this time substitutions will not be allowed.

Since we operate a farmer's market on our farm, we have additional produce and products for sale. Additional products available in our Market include: Miller Farms Grass Fed Beef from cattle on our Farm; Miller Farms pastured Broiler Chickens raised on the pastures at Miller Farms; South Mountain Creamery Milk, Ice Cream, Cheese, Butter, and Cream Cheese; Papa Weaver's Pork; Miller Farms Honey and other Local Honey; JoJo's Jams and Jellies; Shawnee Springs products; Route 11 Chips; and Whitley's Peanuts.

- Changes:** We allow one pick-up day change per customer (Ready-to-Go customers) and one vacation per customer. Please see #2 and #3 below for our rules on pick-up day changes and vacation schedules. If at any time you would like to make arrangements for a friend to pick up your CSA share, please feel free to do so. This is actually very helpful to us.
- “Ready-to-Go” Scheduled Pick-up Day Change:** When you complete the CSA application for a “Ready-to-Go” CSA, you will select one designated pick-up day that remains in effect during the length of the agreement. Pick-up location is the Market on our farm. You are responsible for picking up your share on your selected pick-up day. We allow one pick-up day change per customer, which must be coordinated with us one week in advance. Pick-up day changes that are not coordinated one week in advance will be considered a missed pick-up and your share for that week will be donated.
- Vacation:** We allow one vacation week per season per customer. If you have signed up for the full season 33 week option, then you will have 3 vacation weeks. There is one vacation week allowed for each 11 week season. Your vacation week must be coordinated with us one week in advance. If you will be on vacation and unable to pick up your share one week, you must provide us with notice one week in advance in order to receive a double share the week before or the week after your vacation. Vacations that are not coordinated one week in advance will be considered a missed pick up and your share for the week will be donated.
- Refunds:** WE DO NOT OFFER REFUNDS!
- Missed Pick-ups:** If you miss your pick-up, contact us ASAP (info@millerfarmsmarket.com) and we will try to work with you to make sure you are still able to pick up your share.
- Your reusable cloth Miller Farm cloth bags:** These bags are yours to keep. Bring your bags to the Farm each week when you pick up your weekly share.
